SUBJECT: CURRENT STATUTORY COURT SURCHARGES AND ASSESSMENTS ON CRIMINAL AND CIVIL FINES, PENALTIES, FORFEITURES, TRAFFIC VIOLATIONS, AND LOCAL ORDINANCES

A.R.S. § 41-1273 requires the Staff of the Joint Legislative Budget Committee to submit a report to the Committee on or before December 1, 2019 and once every 7 years thereafter on the statutory fines, penalties, and forfeitures collected by the courts. The report is required to include the following:

1. The current amount of each surcharge and assessment collected on every fine, penalty and forfeiture imposed on criminal offenses, civil traffic violations, violations of local traffic ordinances, or for violations of the Game and Fish statutes.
2. The items for which the collected surcharge or assessment monies are used.

Statute currently imposes surcharges totaling 78.0% and assessments totaling \$44.00 per fine. With a base fine of \$100, the 78.0% surcharge would be \$78.00, and the assessment would be \$44.00. According to the most recent court data, \$75.8 million was collected from these surcharges and assessments in FY 2018. Attached is a table with detail on each individual surcharge and assessment.

This report only includes the surcharges and assessments charged on all fines, penalties and forfeitures. As a result, some specific statutory surcharges and assessments are not included. For example, statute also imposes a \$250 DUI assessment on DUI charges.

1/ Laws 2018, Chapter 237 reduced the CJEF surcharge from 47% to 42% beginning in FY 2019. The bill also created the new Victims' Rights Assessment and set it at a flat \$9.00, which was first collected in FY 2019.
